### **WCHS Supports Historic Preservation**

The Washington County Historical Society's Preservation Committee is seeking nominations for our 2023 awards program. The program recognizes community members who protect the county's history either by structural and land preservation or the creation of programs that encourage responsible stewardship and increase awareness of Washington County's historic roots. Awards are considered each year for projects that rehabilitate, restore, or continuously maintain buildings of significance in Washington County, or that adapt such buildings for contemporary use. Individuals and groups can also receive awards for outstanding efforts to encourage historic preservation, including preservation of buildings, sites, records, etc.

**This year's deadline for preservation nominations is July 31, 2023.** New applications forms are now available online on the WCHS website: <https://wchs-ny.org/preservation-awards/> We will announce our 2023 winners at the WCHS Annual Membership meeting this October 2023.

With the month of May recognized as Historic Preservation month, we hosted two public talks on preservation topics recently as part of our efforts to educate the public about historic preservation in Washington County.



On May 11 at the WCHS headquarters in Fort Edward, architectural historian and WCHS trustee, Susan Arena, led a program titled "Anatomy of Buildings: Architectural Vocabulary and Identifying 19th Century Styles". She offered a brief overview of common language used to describe buildings and an introduction to 19th century architectural styles found in Washington County. Attendees learned about the evolution of influences on residential buildings and how to identify stylistic elements, and were tested with a pop quiz at the end of the program. Susan Arena is an Architectural Historian with experience completing historic resources surveys, National Register nominations,

preservation planning, and educational programming. She has worked in non-profit, private, and public sectors, collaborating with State Historic Preservation Offices in New York, Massachusetts, Rhode Island, and Connecticut as well as many regional organizations.



On May 18 at the Historic Salem Courthouse, WCHS hosted the program "What You Should Know About Historic Designations and Funding Sources". This educational program was led by Janna Rudler from the Preservation League of NYS. We also welcomed Frances Stern and William Floyd of the NYS Historic Preservation Office as additional presenters for the event. Janna provided information about the League's grant and technical services programs, an overview of the State and National Registers of Historic Places, historic districts, and financial incentives for historic preservation available to historic property owners. Janna Rudler is the Grants and Technical Services Manager at the Preservation League, which is the statewide non-profit dedicated to historic preservation advocacy, education, and grants since 1974. They advise non-profits and municipalities in achieving their preservation goals, offers technical support and referrals to all who seek assistance in their preservation efforts, and oversees the League's grant programs.

## **What is the National Register of Historic Places?**

The National Register of Historic Places was established in 1966 as part of the National Historic Preservation Act. The Register is administered by the National Park Service (NPS) who works in conjunction with state historic preservation offices (SHPO) to review and approve nominations. The purpose of the Register is to recognize buildings, sites, districts, structures, and objects of historical significance and worthy of preservation. As of the end of 2020 the Register included more than 96,000 entries representing more than 1.8 million resources through individual listing and districts.

Does listing on the Register prevent a property owner from making alterations to their building? No, as long as no public funding is being used. However, a benefit of inclusion on the Register is access to many grant and tax credit opportunities, which promote retention and preservation of the country's historic environment. Use of grant or tax credit funding generally requires adherence to the Secretary of the Interior's Standards for Rehabilitation, ensuring historical integrity is maintained. Funding opportunities vary in terms of what expenses they cover and the frequency with which they are awarded. Grants are generally restricted to non-profits and municipalities and are awarded on an annual or semi-annual basis, while tax credits are available for privately held properties and are continuously accessible.

In New York there are three options for tax credits: Commercial, Homeownership, and Barn. The commercial credit, also referred to as the Rehabilitation Investment Tax Credit, applies to income-producing properties listed on or eligible for the Register, and is reviewed by NPS and SHPO. Projects may receive a 40% (20% state and 20% federal) return on qualifying expenses. The homeownership credit, offered by NYS, applies to primary residences listed on or eligible for the Register. The program provides a 20-25% return for a wide variety of improvements. Lastly, the Barn program offers a 25% credit for rehabilitation of barns intended for agricultural use and built prior to 1946. With all programs, specific restrictions apply and proposed changes must be approved prior to start of work. For additional information on tax credits and grants, please see list of resources below.



***Did You Know...***the Wing-Northup House in Fort Edward (the home of the Washington County Historical Society) was listed on the National Register of Historic Places in 2008?



The house was built c. 1815 by entrepreneur Daniel Wood Wing as a two-story, five-bay, center entrance brick building, with a two-story brick ell. A one-story brick side wing was added about 1880. The property was acquired in 1884 by James M. Northup, and in 1982 by the Washington County Historical Society.



## AUTHOR TALK:

### Washington County's 123rd Regiment and the Experiences of Sergeant William J. McCollum During the Civil War

WITH CHARLES AVRINA



On June 6, WCHS hosted a presentation with author Charles Vavrina about his book *"When this Cruel War is Over: The Civil War Letters and Diary of William J. McCollum, Company F, 123<sup>rd</sup> New York Volunteer Infantry"*. The book contains 94 letters spanning the years 1862–1865 and details from the 1865 diary of Sergeant McCollum. Charles S. Vavrina, PhD, is a Professor Emeritus of Horticulture at the University of Florida. He came by this collection of letters when his friend and colleague, John McCollum Stevely, shared with him his great-grandfather's correspondence home during the war.

The event was well attended. The author had copies of the book for purchase, and he signed copies for attendees. The Washington County Historical Society also sells this title at the Book Shop located in the Wing-Northup house in Fort Edward or it can be purchased online through WCHS at [www.wchs-ny.org](http://www.wchs-ny.org).

The event was held at the Hartford Baptist Church in Hartford, NY. Attendees were able to visit the 123<sup>rd</sup> Enlistment Center across the street from the church prior to the program. ## **Fond Memories Of A Special Family Tradition**

When I was growing up, there were certain cookies my mother Rita Huntington made every holiday. They were bon-bon cookies, filled cookies and molasses cookies. Bon-Bons were small round balls with a candied cherry or walnut in the center with icing drizzled over the top. Filled cookies were a large two layer sugar cookie with a date mixture in the center. The molasses cookie was a large thick cookie with a cake like texture. She would make the filled and molasses cookies other times of the year, but she always made them at Christmas. It is the molasses cookie recipe and story that I will share with you.

My mother was born in 1932 and grew up on Davis Street in Whitehall, NY until she was 16 when her parents, Albert and Marjorie Briggs, moved to the hamlet of Clemons in Dresden, NY. Next door to her growing up lived an elderly couple, Kaye and Jessie Salmons. In the 1940 census he is 80 years old, and Jessie is 73. Kaye was from England and Jessie was from Holland. My mother remembers Kaye as a perfect English Gentleman. In the summer he would wear a white suit and Panama hat and have a cane and would walk around the block. Almost every week Jessie would bake a batch of molasses cookies and before my mother was born, she would call my grandmother over to the side yard and give her seven cookies — one for each day for my uncle Stan. When my mother came along, Mrs. Salmons continued that but gave my grandmother two cookies for every day — one for each child. She would never give my grandmother the recipe. A few days before my grandparents were to move, Mrs. Salmons called my grandmother over and gave her the recipe for the molasses cookies.

My grandmother continued to make the molasses cookies and when my mother was married and having a family, she gave my mother the recipe. My mother also shares a story about the cookies and how she would make them every year for the Church Bazaar and John Moore would have his wife Myrtle buy all the molasses cookies before anyone else could buy them!

My mother is now 90, and supervises and gives advice when I make them. It's one of those old recipes that has things like "add flour until it feels right". So, it does take some getting used to. I am also happy to know that my mother's grandchildren have the recipe so it can continue for another generation.

1 cup sugar  
1 cup shortening  
1 cup molasses (my mother always preferred Brer Rabbit green label)  
1 egg  
1 cup cold water  
2 teaspoons baking soda dissolved in 2-3 tablespoons warm water  
2 teaspoons cinnamon  
Dash of salt  
About 5 cups flour

Mix the first 3 ingredients then add the rest. Add flour until it feels right. Just beyond being sticky to the fingers. Take portions of dough and roll or pat out to just under  $\frac{1}{2}$ " thick. My mother always patted her dough out and did not roll it. Use enough dough at a time to cut out 4-5 cookies. Use a 2  $\frac{1}{2}$ " -3" biscuit or cookie cutter.

Place on cookie sheet and bake at 350 degrees for 15-20 minutes or until you gently touch the top and it does not indent.
